## **Introducing WaterSafe**

WaterSafe is a new nationwide hub and online search facility for all suitably qualified approved plumbers working in the UK and provides customers with a free online directory of trusted, professional plumbers.

WaterSafe essentially links eligible recognised plumbers from the seven existing Approved Contractors' Schemes:

- Association of Plumbing and Heating Contractors' (APHC)
- Chartered Institute of Plumbing & Heating Engineering (CIPHE)
- Scottish and Northern Ireland Plumbing Employers' Federation (SNIPEF)
- Water Industry Approved Plumbers' Scheme (WIAPS)
- o Anglian Water's A Plus
- Severn Trent's WaterMark
- Thames Water's TAPS

## Who can join?

All members of WaterSafe must have passed an NVQ level 2, 3 or craft certificate in plumbing and have an accompanying endorsed Water Regulations certificate. Alternatively, **experienced plumbers can opt to take the new course** BPEC have developed – the Level 3 Award in Safe Systems of Hot & Cold Water Sanitation. The purpose of this qualification is to provide a vehicle by which experienced workers within the plumbing sector can demonstrate the practical skills and theoretical knowledge required for registration with the WaterSafe scheme. The qualification is designed solely for experienced workers with at least 5 years' industry experience on the job. Each prospective student must successfully complete an initial assessment as stipulated by WaterSafe. This new qualification also incorporates the BPEC Water Regulations qualification.

Once qualified, every prospective WaterSafe member must then join one of the seven Approved Contractors' Schemes listed above. Fees and coverage areas vary.

# How long does the course take?

The course is 69 taught hours, this assumes that the applicant holds sufficient and relevant experience. Suitability will be established through proof of five years' working in the trade followed by an initial assessment.
